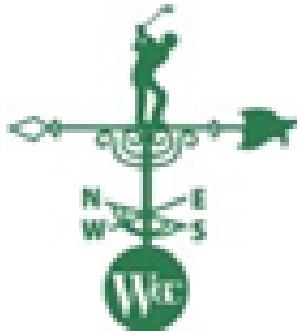

WGC 2023 full golf membership details.

Dues are by age as of January 1st each year.

Initiation fee: For full golfers an initiation fee of \$2500 is due upon acceptance, or if committing to two years it can be paid in two payments of \$1250 each. First payment due with acceptance and the second due in January.

A refundable stock purchase of \$510 required at approval.

Other:

Range fee is \$125 for individual and \$200 when including a spouse. plus tax.
Handicap fee is \$36.25 per golfer.

Food and beverage minimum is in 3 trimester periods.
For age 18-34 \$300 per trimester. 35 and up \$400 per trimester.
Social \$240 per trimester
See dues schedule for details.

Optional bag storage and locker are \$150 / year each.

When adding a spouse;

Spouse additional restaurant minimum is \$80 / trimester.
A refundable investment of \$102.00 WGC stock is required at time of commitment.
Women's Lockers available at \$75/ year

Members are responsible for any current and future assessments implemented by the Board of Governors. Current capital assessment for course equipment is \$200 per year for all full golfers and \$80 per year for social members, for years 2023-2026.
